

Thank you for playing in the **Sierra Nevada BCA Pool League.**

Please read through the rules of play found on the website. I will be available for questions &/or help with any questions you may have. I usually play league on Tuesday's and Thursday's in Carson City and would appreciate questions at any other time than during my league play :-)

The BCAPL scoring app is the preferred scoring option for all match's. If a scoresheet is used and no scoring is submitted by app by either team, a pic of the scoresheet must be texted to Cindy or Kristen before placing and dropping your envelope. Team stats may be delayed for teams not using the scoring app.

An explanation of monies with team name and match date as well as any other \$ allocations must be included in or on the envelope. I have included a page of **payment slips for your use**. Envelopes must be dropped within 48 hrs after the end of your match. Please drop your envelope by your own hand. Each captain is responsible for their own monies. Late fees may be applied for any teams dropping incomplete information or short on money.

Dropbox Locations:

Carson City: Lamplighter, Allstar, Ed's Dog House, Bulldogs

Reno: The Local (located in the storeroom, ask bartender to let you go in to drop your own envelope)

Payout will be posted and paid within 2 weeks of session. Captains are responsible for paying out their teams and should inform their players as to their intended payout policy.

\*\* Note that we are allowing 1 time out per rack during league play. **ONLY THE PLAYER MAY ASK FOR THE TIMEOUT.** If any team member or any other person suggests a time out to the active player, that active player will loose the timeout for that game. A warning should be given to the offending team. If a "time out" offense is repeated, a foul can be called on the offending team and a ball in hand to the opponent.
